### **Special and / or sensitive personal data that we process**

Our website and / or service does not intend to collect data about website visitors who are younger than 16 years. Unless they have permission from parents or guardians. ### **For what purpose and on what basis we process personal data**

Euronorm B.V. processes your personal data for the following purposes:

### **How long we store personal data**

Euronorm B.V. does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected.

### **Sharing personal data with third parties**

Euronorm B.V. provides only to third parties and only if this is necessary for the execution of our agreement with you or to comply with a legal obligation.

**Cookies, or similar techniques, that we use**

Euronorm B.V. uses functional and analytical cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website. Euronorm B.V. uses cookies with a purely technical functionality. These ensure that the website works properly and that, for example, your preferred settings are remembered. These cookies are also used to make the website work well and to optimize it. In addition, we place cookies that keep track of your surfing habits so that we can offer customized content.

You can opt out of cookies by setting your internet browser so that it does not store cookies anymore. In addition, you can also delete all information previously saved via the settings of your browser.

**Google Analytics**

Euronorm B.V. uses Google Analytics to keep track of how users use the website. Through our website a cookie is placed from the American company Google, as part of the "Analytics" service. We use this service to track and get reports on how visitors use the website. Google may provide this information to third parties if Google is legally obliged to do so, or if third parties process the information on behalf of Google. We have no influence on this. The information that Google collects is anonymised as much as possible:

- \* We have a data processing agreement with Google;
- \* The last digits of your IP address are masked.
